The term of the chairperson and members shall be two years whereas the term of special invitee will be one year.

The Ombudsperson shall be appointed for a period of three years or until he attains the age of 70 years, whichever is earlier, from the date of assuming office, and shall be eligible for reappointment for another one term.

NOTE:

- 1. The quorum for the meeting including the chairperson, but excluding the special invitee, shall be three.
- 2. A complaint from an aggrieved student relating to the institution shall be addressed to the chairperson, SGRC.
- 3. In considering the grievance before it, the SGRC shall follow principles of natural justice.
- 4. The SGRC shall send its report with recommendations, if any, to the competent authority of the institution concerned and a copy thereof to the aggrieved student, preferably within a period of 15 working days from the date of receipt of the complaint.
- 5. Any student aggrieved by the decision of the SGRC may prefer an appeal to the Ombudsperson, within a period of fifteen days from the date of receipt of such decision.
- For conducting the hearings, the ombudsperson shall be paid a sitting fee, per diem, in accordance with the norms fixed by the respective university and shall, in addition, be eligible for reimbursement of the expenditure incurred on conveyance.
